

Tile Shop Announces Offering of Common Stock by Selling Stockholders

PLYMOUTH, Minn.--(BUSINESS WIRE)-- Tile Shop Holdings, Inc. (NASDAQ: TTS) (the "Company"), a specialty retailer of manufactured and natural stone tiles, setting and maintenance materials, and related accessories, today announced that certain of its stockholders (the "Selling Stockholders") have commenced an underwritten public offering of 4,250,000 shares of the Company's common stock. Certain Selling Stockholders will grant the underwriters for the offering a 30-day option to purchase up to an additional 637,500 shares of common stock on the same terms and conditions to cover any over-allotments.

The Company will not sell any shares of common stock in the proposed offering. The offering is subject to market conditions, and there can be no assurance as to whether or when the offering may be completed, or as to the actual size or terms of the offering.

Citigroup Global Markets Inc., Robert W. Baird & Co. Incorporated and Piper Jaffray & Co. will serve as joint book-running managers and representatives of the underwriters for the offering. Wedbush Securities Inc., Telsey Advisory Group LLC, and CJS Securities, Inc. will serve as co-managing underwriters for the offering.

A registration statement relating to these securities has been filed with the Securities and Exchange Commission (the "SEC") but has not yet become effective. These securities may not be sold nor may offers to buy be accepted prior to the time the registration statement becomes effective.
